AutoCAD® Term License Program

Frequently Asked Questions for Customers

Based on feedback from customers, Autodesk introduced a new AutoCAD® term license. This new offering is designed to help customers meet project demands, while faced with limited budgets, project-based budgets, or simply to meet peak demand requirements in unpredictable markets.

Three important changes to the program include:

- AutoCAD Term Licenses now available in Canada
- Availability of one subsequent term for all new AutoCAD Term Licenses
- The ability to purchase a discounted perpetual license at the conclusion of the term*

The AutoCAD term license offers the same powerful, flexible features found in AutoCAD® software, one of the world's leading 2D and 3D design software, at a lower initial cost to customers.

1. What is the AutoCAD Term License Program?

Autodesk now offers a 12 month stand alone license of AutoCAD® 2010 for \$1,995 USD* SRP to commercial customers in the United States and Canada. Availability of specific releases is subject to change.

2. Why is Autodesk offering a term license for AutoCAD?

Autodesk is always exploring more flexible methods to meet customer needs. The AutoCAD term license is designed to meet the needs of customers who have limited budgets, project-based budgets, or simply need a more cost effective way to meet peak demands for design software.

3. What are the customer benefits of the AutoCAD term license?

The AutoCAD term license assists customers to manage short-term projects and peak demand periods in a potentially more cost effective way. Customers are able to access the proven technology of 26 years of AutoCAD innovation at a term license price.

Additionally, customers with a need to expense software to specific projects may find that a term license option better meets their accounting needs.

The AutoCAD term license offers a lower entry point and may be a desirable solution for some customers to manage their budgets.

4. How does the cost of an AutoCAD term license compare to a perpetual license?

An AutoCAD term license provides customers with a lower cost of entry to use AutoCAD for a 12 month term.

At \$1,995 USD SRP*, the AutoCAD term license is a great solution for those customers who do not wish to purchase a perpetual license at \$3,995 USD SRP* + the annual Subscription rate of \$450 USD SRP*, or have a need to expense the term license against a project budget.

5. Is the AutoCAD term license a good solution for long-term AutoCAD needs?

Since the term license must be repurchased each year at full price, over a three year period the standard AutoCAD perpetual license with Subscription may be more economical, potentially saving \$640 during this period over the AutoCAD term license. See the table below:

6. What is the duration of the term license?

The AutoCAD term license duration is 12 months, and will be activated at registration. Only 12 month terms are available at this time.

7. If I complete my work sooner than expected, can I get a credit for the balance of the term?

AutoCAD term licenses are available for 12 calendar months from the date of activation. Term licenses cannot be temporarily suspended, nor can credits be provided for unused periods during the term.

8. Are AutoCAD Subscription benefits available as part of the AutoCAD term license offer?

No, Subscription benefits are not available for AutoCAD term license customers, and Subscription cannot be purchased with AutoCAD term licenses.

Customers with a need for Subscription benefits such as prior use, extensions, eLearning, or product updates should consider the purchase of an AutoCAD perpetual license with Subscription.

9. Are there any upgrade or cross-grade paths for the AutoCAD term license?

Any time during the AutoCAD Term License period, customers will have the option to purchase a perpetual license of AutoCAD software at a savings of 30% off SRP. Additionally, customers will have the option to renew their Term license for at least 1 consecutive term.

Term licenses are for the version of product purchased. Upgrades which may be commercially released by Autodesk to any future releases of Autodesk product will not be available from a term license. Also, there are no cross-grade paths from the AutoCAD term license to any other Autodesk® product.

Customers that require use of the most current AutoCAD software version, or the flexibility to cross-grade to industry-specific products should consider purchasing the AutoCAD perpetual license with an annual Subscription.

10. What versions of AutoCAD are available as term licenses?

AutoCAD term licenses are available only for AutoCAD 2010. Availability is subject to change as new versions are released.

11. Can the AutoCAD term license be used with 3rd Party software products?

The AutoCAD term license product is equivalent to the perpetual license version in every way, except for the licensing term and networking features. Any AutoCAD-compatible 3rd Party software product can also be used with the AutoCAD term license.

12. Are there any product feature limitations associated with AutoCAD term licenses?

AutoCAD term licenses include all of the functionality of AutoCAD packaged in a 12 month term license. See the next question for limitations on deployment.

13. Will this offer be available for Network deployments?

No, the AutoCAD term license is only available as a standalone deployment. Network deployments can increase license utilization in network environments. Customers requiring the flexibility of network deployments should consider the purchase of an AutoCAD perpetual license which includes this valuable benefit.

14. Are other Autodesk products available in a term license?

Only AutoCAD 2010 software is available as term licenses at this time. While Autodesk will monitor customer feedback on the AutoCAD term license program, there are currently no plans to offer term licenses on any other Autodesk products.

15. Who can purchase an AutoCAD term license?

The AutoCAD term license is available to commercial accounts in the United States and Canada. Government customers are not eligible to purchase AutoCAD term licenses at this time.

16. Where is the AutoCAD term license available?

The AutoCAD term license is only available in the United States and Canada. Multi-lingual versions are available in Canada.

17. What are my options at the conclusion of the 12 month license period?

Customers that have purchased the AutoCAD term license may elect to choose any of the following options at the conclusion of the 12 month license period:

- Allow the license to lapse, and not take any further action
- Purchase a new 12 month term license, or extend the term for their existing version product (new serial numbers will be provided, and product re-install will be necessary)
- Purchase a new perpetual license of AutoCAD software (standard new seat) at a savings of 30% off the new license SRP*
- Purchase any other Autodesk product with or without Subscription

18.Can the 12 month license term be paused once activated?

No, the AutoCAD term license runs for 12 consecutive months once activated, and cannot be paused or temporarily suspended. Customers that expect delays in the use of their term license should consider an AutoCAD perpetual license with Subscription.

19.Can customers combine the AutoCAD term license with other Autodesk promotions?

The AutoCAD term license is not valid with, and cannot be combined with any Autodesk promotion, special pricing or other offers unless specified herein.
